
Message from the Provincial Grand Master

Lifting of the Local Suspension

Earlier this year I issued this statement in the monthly newsletter:

'Brethren, you will no doubt remember, that on the 25th September last year I imposed a local suspension of all Masonic activities in Warwickshire. The reason this was done was to prevent Secretaries and Scribes having to produce and circulate a Lodge Summons, only to have to declare the meeting cancelled. That suspension remains in effect and will probably stay in place until 31st August 2021, but will be kept under review during the coming weeks.'



Well here we are, and yes the Local Suspension ended at mid-night on Tuesday 31st August and we are all raring to go...or are we?

There may be a good number of Brethren who are still anxious about meeting in large numbers or potentially being involved in physical or even close contact with others during our ceremonies; there may be concerns about the procedure at Festive Board or even changing areas. I would ask you all to explore any issue that may arise so as to ensure as far as possible the best solution for all; but let me reiterate; *'that <u>No-one</u> should feel coerced into returning to Lodge activities until they feel safe and comfortable to do so!*






The Provincial Shop






On being Deputy Provincial Grand Master – by Mike Saxon P.Dep.Prov.G.M

What! Me, Deputy Provincial Grand Master? However did that happen, I hear you ask. Well, you and me both. Maybe it was my Machiavellian plan in which I ruthlessly murdered my rivals to get the top job. Watch out Phil. You are next! But no, not at all. I can assure you there was no plan, and no bodies have been found (yet!)

Maybe I have been in a life-size arcade game where, if you press all the right buttons you go to the next level. That is probably a bit more like it. I have definitely pressed some buttons in my time, but only ever accidentally, and never in the right order. Yet here I am.

I once said to the PGM, rather flippantly, that I liked being Deputy Provincial Grand Master as I get all of the influence and none of the responsibility. If only that were true! Yes of course I get some influence some of the time, but the PGM makes ALL of the decisions. Some you win, some you lose, and then you move on to the next hot topic.



There are responsibilities that go with the job, but they are not burdensome. One of the Chains will preside at every Installation meeting, and all Advancements and Elevations if at all possible, but since there are three Chains I get one third of the workload, and it's not really work because going to visit the lodges is the best part of the job. We get to be entertained by the lodge members performing ritual, and that can be great fun. There is a bit for the Presiding Officer to do in delivering the Address to the Master or Commander, but once you have done it a few times it gets easier, and there is always the escorting DC on hand who, in theory, knows it better than you and will jump in with the right prompt at the right time, hopefully! There are, as well, the parish notes to give at the festive board, which vary from meeting to meeting, but I take a checklist with me in an effort to ensure I don't miss anything important. Above all at the meetings it is important to try and get to speak to everyone in attendance. I like to do that before the meeting starts in order to reassure and encourage the participants who can be worried about the task ahead. A few quiet words can often ease their tension. Best of all I get to welcome the candidates to the Province and to congratulate them on their foresight in joining such a fantastic Order as the Mark.

If there was a written job description for the role of Deputy PGM it would probably be quite short and say something like *"support the PGM; support the Province; and do whatever the PGM tells you to do."* There are times when I do actually have to be substitute for the PGM, sometimes at short notice, but those occasions are few and far between, and mostly local, although I did once have to go to London to attend a meeting of PGMs. An interesting day out! I also get to visit other Provinces at their annual meetings and fly the flag for Warwickshire. There are other less exciting things to do, like attending Executive and other committee meetings which are nonetheless important in the smooth running of the Province.

When I was first appointed Deputy, at the PGMs Installation in 2017, one of the visiting Provincial Secretaries, who I knew well from my days as a Provincial Secretary, saw me clearing up papers from the tables after lunch. He said that now I was Deputy PGM I shouldn't be doing that, and I told him that Deputy PGM was the same as Deputy Secretary, except that now I get to sit on the top table. I see the role as being a support for all levels within the Province, and I am happy to give that support whenever and wherever it is needed.

Ron Albutt Lodge of MMM Meeting 31st August 2021

Scheduling a Lodge Meeting a week early sounds like a good idea when the usual date clashes with Grand Lodge at Mark Mason's Hall, particularly when you are the Provincial Grand Steward's Lodge as is the case with the Ron Albutt Lodge No.1818 where many members may wish to attend the London Meeting. The only issue is that the meeting then had to open with three dispensations! Firstly to change the date of the Meeting, secondly to hold the Meeting during the Provincial suspension and thirdly to allow W.Bro Joe McCollum to be installed when already in the chair of two other Lodges of MMM. During a very enjoyable meeting W.Bro Mike Grillage, as outgoing Worshipful Master, installed W.Bro. Joe in exemplary manner and with Mark Masonry opening up everything looks set fair for this Lodge and hopefully the rest of the Mark and RAM Lodges in the Province.



The Duties We Owe to Mark Masonry in General

A commentary of snippets from the Constitutions and Regulations of the Order.

115. (i) Every Lodge has the power of framing by-laws for its government provided that they are not inconsistent with the Constitutions and Regulations. The by-laws must be submitted to the General Board – in Provinces or Districts through the Provincial or District Grand Master – for the approval of the Committee, and when approved a fair copy must be sent to the Grand Secretary for registration.

(ii) No alteration of, or addition to, the by-laws of a Lodge shall be made unless notice of a motion for such alteration or addition be given at a meeting of the Lodge, and the summons for the next meeting, which shall be circulated at least seven days before the date of such meeting, contain or be accompanied by a copy of such alteration or addition. If such alteration or addition is approved by a simple majority, with or without amendment, at such meeting, the by-laws as amended shall forthwith be submitted to the General Board as above, and if approved they shall thereupon become of force without need for confirmation at a subsequent meeting, unless the existing by-laws require such confirmation or the General Board directs that they shall be submitted for confirmation.

(iii) Should the new by-laws as passed by the Lodge differ from the copy on, or sent with, the summons, the General Board may, if it think fit, require the by-laws to be submitted for confirmation to a further meeting of the Lodge.

(iv) By-laws, or any alteration thereof, which have been approved by the General Board, shall be deemed for all purposes to be valid and to have been validly enacted and no question of any irregularity in procedure shall thereafter be raised. Provided that if it shall thereafter appear to the General Board that, by reason of changes in the Constitutions and Regulations or other cause, the by-laws of a Lodge contain anything inconsistent therewith, the General Board may withdraw its approval and require the Lodge, whether or not it be a Province or District, to amend its by-laws to bring them into harmony with the Constitutions and Regulations.

Lodge by-laws must be approved by both the Provincial Grand Master and the General Board at Mark Master Masons before they come into effect. Remember - every Brother is entitled to a copy of the bylaws at their Advancement and again at Installation. Grand Lodge produces template by-laws which make sure that nothing contained within them is contrary to the constitutions of the order. It's a good idea to revisit by-laws occasionally to make sure they are still relevant and up-to-date.

99. The Master is responsible for the due observance of the by-laws of the Lodge over which he presides, a copy of which shall be presented to him on his installation.

Most importantly, it is the Master (or commander of RAM Lodge) who is responsible for making sure that the Lodge and it's members conduct their business in line with their by-laws. It's therefore important that a newly Installed Master makes sure he is well informed on both the constitutions and the Lodge by-laws.
